Cllr K White reported on the Town and Parishes forum. Huge concerns over the proposed changes to planning with a strong push to privatise the planning system. This is likely to have huge impact potentially enabling

developers to push through large projects without opposition and result in councils losing control of local planning. General feeling that this is going against localism and re-enforces the need for village and neighbourhood plans. Council approved production of village plan, 300 households in parish.

ACTION: Clerk to proof read and send copy to Dick Whittington at WERN for comment. Clerk to ascertain printing costs.

6b. TO AGREE next steps for Neighbourhood Plan including publicising it at Annual Parish Assembly meeting. Some responses have been returned to village shop, Cllr Line to collect. Analysis of responses will be needed **ACTION: Promote neighbourhood plan at Annual Parish Assembly meeting**

6c. To FINALISE arrangements for Annual Parish meeting

Grant recipients and local groups invited to meeting and speakers arranged. Clerk to invite a village hall representative to give the hall report. The Chairman's address has been kindly prepared by the former clerk. Meeting agreed to provide tea and coffee. Cllr K White to produce publicity to promote neighbourhood plan and bring a supply of response forms.

In response to their invitation to the Annual Parish Assembly meeting, Cromhall's Poor Allotment Charity has advised that the charity is having difficulty recruiting some new trustees. As they are appointed by the Parish Council they have requested suggestions for potential Trustees.

Clerk reported that it appears anywhere under phase 1 who got broadband will not be able to access further state aid unless it can be proved some sort of negligence in the way broadband was brought to the area. It is clear that fast broadband was brought to an area but this did not mean it would actually reach every household equally. Those still on old cables and with a single connection to a group of households would inevitable suffer lower speeds. The reality may not be quite what everyone believed would happen.
