Minutes of the meeting on 12th July 2017 were accepted as a correct record of the meeting and signed by the Chair.

NO. 4 PUBLIC PARTICIPATION:

Concerns were raised over the large illuminated sign proposed at Cromhall Chapel which will distract drivers on the main road. Further concerns were raised at the proposal to cut down the Jubilee tree at Cromhall Chapel to accommodate the proposed sign.

The hedge beside the pavement on Church Lane is overgrown and encroaches over three quarters of the pavement forcing walkers into the road.

Many of the pavements along the main road are becoming overgrown.

The step up to the stone stile on OCR/15/10 is too high for many users.

Council agreed to report footpath issues to South Gloucestershire Council.
