# MINUTES OF THE PARISH COUNCIL MEETING HELD WEDNESDAY 7<sup>th</sup> NOVEMBER 2018 at 7.30pm IN CROMHALL VILLAGE HALL

#### 11/2018. No 1 APOLOGIES:

Apologies were received from Cllr Steve Aston (SA) and approved by council.

## 11/2018. No 2 DECLARATIONS OF INTEREST: in any items on agenda:

#### 11/2018. No. 3. ADOPTION of the MINUTES:

Minutes of the meeting on 10<sup>th</sup> October 2018 were accepted as a true record and duly signed by the chair.

## 11/2018. No. 4 PUBLIC PARTICIPATION:

None. Standing Orders were suspended to receive report from District Councillor John O'Neill.

VAS signs. Complaints have been received over speeding around Drews Orchard area where there is no footpath and the need for an eastward VAS sign. Requested Longcross VAS is moved to Tortworth Road, however according to South Gloucestershire council (SGC) this VAS cannot be moved (reasons unknown). Speed reading will be taken on Tortworth Road where excess speeding is a problem.

Recent serious incident involving Leyhill absconder has highlighted the flawed reporting system and problems with early warnings. There is a Police investigation and an urgent meeting requested between key stakeholders is awaited. This is the second serious incident in the Cromhall area in a year. Leyhill prison has always been part of the community but there are now serious concerns over the vetting process for inmates and the growing risk to the community. SG Ward Cllr O'Neill will keep the parish council appraised of any developments. It was noted that Cromhall parish council had received no notification or reassurance.

Legal challenge to Warners Court development dismissed. Hill House Farm option for 280 houses will form part of the JSP.

Council requested update on signage to prevent HGVs using shortcut through Spring Lane to Cromhall Lane. The council has received further complaints from Tortworth Estate about inappropriate HGV use of lanes around Sodom Mill with evidence of contact with telecom/power lines and a councillor has witnessed problems with the HGV driver saying the lack of signage encouraged him to use the route. Requests to date have met with reluctance to add further signage. Matter may be referred to formal investigation scheme.

Broadband issues in Bibstone remain unanswered.

SG Ward Cllr O'Neill to make enquiries over the lack of progress on the entrance gates project.

Compliance period with enforcement notice has expired with no sign of any actions. SG Ward Cllr O'Neill to follow up.

## 11/2018. No. 5. PLANNING 11/2018. 5ai Applications

PT18/4215/F South Face Cowship Lane Cromhall Wotton Under Edge South Gloucestershire GL12 8AY Erection of first floor extension and alterations to roof line to form two storey dwelling with associated works. **Resolved** to raise concerns. *Cromhall parish council is concerned about the overbearing nature of the proposal and its design and appearance. Policy states that 'Design should ensure that extensions do not harm the balance and proportions of the original building and street scene'. 8.12 further states that 'Extensions should either follow the building line and roof ridge height, such as at the end of a terrace, or appear subservient to the main dwelling house (by at least 400mm) by setting it back from the front wall and down from the ridge height by an equal distance. Roof shape should also reflect the existing building, usually pitched.'. This property is surrounded by a small number of bungalows and the design will have a dramatic effect on the street scene.* 

**11/2018 5aii.** PT18/497/0 Land to the rear of South Face Cowship Lane Cromhall. Erection of 2 No detached dwellings (outline) with access determined all other matters reserved

Resolved to raise concerns. Cromhall parish council has concerns over the proposal. 3.2 NPPF para 58 requires that development should, 'respond to local character and history, and reflect the identity of local surroundings and materials, while not preventing or discouraging appropriate innovation'. 3.4 Core Strategy Policy CS1(1) requires that; 'siting, form, scale, height, massing, detailing, colour and materials, are informed by, respect and enhance the character, distinctiveness and amenity of both the site and its context'

The inherent character of an area shows the current street scene is predominantly one of linear development. The proposal changes this pattern. There are questions over

- how this development 'conserves and where appropriate enhance the quality, amenity, distinctiveness and special character of the landscape' Policy PSP2 Landscape Protection and Enhancement
- impact on residential amenities in line with Policy PSP8 Residential Amenity 4.9/4.10

The council disagrees that the proposed 2 no. dwellings will result in a negligible impact in terms of vehicular movements and effect on the character of the area in accordance with policy PSP38. This proposal alongside applications to substantially extend South Face and a further application to convert an associated barn into two dwellings will cause increased vehicular movements. Using SGC figures of 1.5 vehicles per household would result in a minimum of 7.5 vehicles for this three-part development using the same access. Bus services in Cromhall are negligible and with minimal local amenities use of private vehicles is the only viable method of transport.

Refused Resolved to raise concerns. Cromhall parish council has concerns over the change of use application. *3.2 NPPF para 58 requires that development should, 'respond to local character and history, and reflect the identity of local surroundings and materials, while not preventing or discouraging appropriate innovation'. <i>3.4 Core Strategy Policy CS1(1) requires that; 'siting, form, scale, height, massing, detailing, colour and materials, are informed by, respect and enhance the character, distinctiveness and amenity of both the site and its context'* 

The inherent character of an area shows the current street scene is predominantly one of linear development. The proposal changes this pattern. There are questions over

- how this development 'conserves and where appropriate enhance the quality, amenity, distinctiveness and special character of the landscape' Policy PSP2 Landscape Protection and Enhancement
- impact on residential amenities in line with Policy PSP8 Residential Amenity 4.9/4.10

The council is concerned that the application to convert this associated barn into two proposed dwellings will result in increased vehicular movements and effect the character of the area in accordance with policy PSP38. This proposal is in addition to applications to substantially extend South Face and build a further 2 no. dwellings to the rear which will all cause increased vehicular movements. Even using SGC figures of 1.5 vehicles per household this would result in a minimum of 7.5 vehicles for this three-part development using the same access, the actual number of vehicles is likely to be higher. Bus services in Cromhall are negligible and with minimal local amenities use of private vehicles is the only viable method of transport.
