Minutes of the meeting on 7th November 2018 were accepted as a true record and duly signed by the chair.

Cllr Hobbs raised issues of concerns from the public.

There are concerns over the lack of signage and SatNav instructions which resulted in a Rudrum coal lorry becoming serious stuck in Knapp Lane (unsuitable for HGVs). This incidence prevented the farmer from accessing his cattle and necessitated the farmers assistance to extract the lorry.

There are worries over a recent accident outside Cromhall Chapel, which occurred at 4.45pm on a misty evening at a time when the chapel signage was illuminated raisng fresh concerns over the brightness of the illuminations.

Resolved to raise concerns. Cromhall parish council is concerned about the lack of detailed information on this proposal which prevents the council from responding effectively. On the information available the council is deeply concerned about the entrance and access for this proposal which it believes is too close to a dangerous bend on a heavily used link route to the M5 including HGVs. The inherent character of an area shows the current street scene is predominantly one of linear development. The proposal which is believed to be outside the settlement boundary, beings changes to this pattern, and could lead to further development in the adjacent field leading to greater concerns over access and traffic. There are questions over how this proposal will
